Subject: Registration of FBOs using the platform of Common Service Centre-Special Purpose Vehicle (CSC-SPV).

It has been decided that the time period for special promotion i.e. FSSAI funding the CSC service charge of Rs 30/- for Registration of FBOs has been extended upto **31st March, 2017**.

2. It has been brought to notice that many States/UTs have not opened bank accounts for direct transfer of fee collected through CSC. In this regard it is clarified that the amount being collected through CSC may be processed similarly as the overall registration fee is being processed in the State/UT. The State/UTs may share their account/ challan details with the representatives of the CSC to expedite the process of transfer of funds collected so far.

3. The list of State Representatives of CSC is attached herewith for States/UTs to liaison with them for operational queries, training programmes, etc. It is encouraged that the States/UTs may utilise this facility of Registration done through the Common Service Centre.

4. Commissioners of Food Safety of States/UTs may forward any queries relating to the CSC platform to ensure that the registrations of FBOs are expedited.
