Hence, there is a violation of clause number 2.2.1(3) and 2.3.1 (5) of Food Safety Standards (Packaging & Labelling) Regulations, 2011 as the product is misleading, misbranding and create an impression in consumer minds regarding the nature of product as instant coffee.
