10	After successful submission of online application, do I have to forward hard copy of online application alongwith hard copies of certificates to FSSAI	No. The candidates are not required to send hard copies of online application and certificates to FSSAI after successful submission of online application. However, the same are required to be produced by the candidate at the time of scrutiny of applications at the time of written test/interview, if shortlisted for the same.																																		
11	Can I apply for more than one post	Yes. You can apply for more than one post, in such case you are required to fill the form separately through On-line mode only.
