In this regard, it is informed that the issue related to the use of Diatomaceous Earth as a processing aid for filtration of honey is being examined by FSSAI and till the final decision on the use or otherwise of the same is taken by FSSAI, an **interim relaxation** to the industry is hereby given by allowing the use of Diatomaceous Earth as a processing aid for filtration of honey and no enforcement action solely on the basis of use of the said material as a processing aid may be initiated against any FBO manufacturing honey and till then the directions issued vide this office letter of even No. dated 31.07.2020 (Copy attached) are kept in abeyance.

However, the above relaxation for usage of the said processing aid shall not be treated as any relaxation of notified Standards of honey including the requirement of minimum pollen counts etc. as notified under Food Safety and Standards (Food Products Standards and Food Additives) Regulation, 2011 as amended from time to time and also does not preclude the FSOs/DOs from routine sampling, surveillance, enforcement etc. in honey.
