Subject: Extension of timeline for compliance with the direction dated 27th January, 2020 issued under 16(5) of Food Safety and Standards Act, 2006 regarding compliance of commercial feeds/feed materials intended for meat and milk producing animals with relevant BIS standards.

Reference is drawn to the direction of even number dated 14th July, 2021 regarding the subject mentioned above wherein the timeline for the compliance of the provision related to commercial feed intended for cattle with Bureau of Indian Standards (BIS) specifications for Compounded feeds for Cattle (IS 2052:2009) and to carry a BIS certification mark on the product label was extended up to 1st January, 2022 for those businesses (listed in the Annexure - 1 to the said direction) whose applications for BIS certification/licensing were under process then.

2. Now based on the updated status of applications of businesses for grant of license/certification for their product (compounded cattle feed) currently under process with BIS, the Annexure - 1 of the direction of 14th July 2021 list of applicants stands revised as attached herewith.

3. This issues with the approval of the Competent Authority in exercise of the power vested under Section 16(5) of the Food Safety and Standards Act, 2006.
