- 2. REGULATORY COMPLIANCE

Extending the facility of Instant issuance of licenses/registrations across Nation: To facilitate ease of doing business, FSSAI has extended the provision of instant issuance of licenses/registrations on 31st Aug 2024 across the country excluding Chandigarh, Himachal Pradesh, Manipur & Meghalaya (where the facility will be enabled after incorporating State-specific requirements). As of 02nd Sep 2024, 771 Licenses and 7038 Registrations have been issued under this provision.

INFORMATION TECHNOLOGY

A.) Global Food Regulators Summit (GFRS) 2024

The development of the **Global Food Regulators Summit (GFRS) 2024** portal (https://gfrs.fssai.gov.in/2024) has been successfully completed. The GFRS portal is a comprehensive platform designed to facilitate the upcoming summit, which aims to bring together global food regulators, policymakers, and experts to discuss and collaborate on pressing issues related to food safety and regulation.

Key Features of the GFRS 2024 Portal:

- Interactive Agenda and Session Management: The portal allows attendees to view and register for various sessions, workshops, and panel discussions. It provides realtime updates and notifications on any changes to the agenda.
- Networking Opportunities: A dedicated networking module enables participants to connect with other attendees, speakers, and exhibitors. The portal also includes features for scheduling one-on-one meetings and discussions.
- Knowledge Sharing: The portal provides access to a wide range of resources,

including research papers, session presentations, and policy briefs related to food safety and regulation. This section aims to promote knowledge sharing among participants.

Live Streaming and Recorded Sessions: For those unable to attend in person, the
portal offers live streaming of key sessions and makes recorded sessions available for
later viewing.

This portal will serve as a critical tool in facilitating international dialogue and collaboration on food safety standards and practices.

B.) Implementation of SMS Notification Services Across Eat Right India (ERI) Initiatives

The IT Department has successfully implemented SMS notification services across various Eat Right India (ERI) initiatives, including School, Station, Place of Worship, Fruits and Vegetables Market, Campus, and Street Food Hub.
