- Work on "Setting up of Microbiological Section and Installation of Equipment on Turnkey Basis" is under process for the following laboratories: Aurangabad, Jaipur, Mysore, Thiruvananthapuram, Bengaluru, Belagavi, Bhubaneshwar, Vadodara, Patna, Bhopal, Solan, Varanasi, Ranchi, Singtam, Agartala, Guindy, Imphal, Puducherry, Kolkata and Haryana (Lab in Chandigarh).
- FSSAI and M/s Merck life sciences private limited have jointly conducted the National Surveillance for testing salmonella in Fish and Fish Products. Samples of processed fish products from organized sector were collected by Central Food Safety Officers (CFSOs) from 3 regions Delhi-NCR, Kolkata, Kochi and the samples were analysed at Center for Microbiological Analysis Training (C-MAT) lab at National Food Laboratory, Ghaziabad, National Food Laboratory, Kolkata and Central Institute of Fisheries Technology (ICAR CIFT), Kochi. Data collation, analysis and report generation is under progress.

#### REGULATORY COMPLIANCE

• Implementation of Rs. 100 Registration Fee Waiver for Street Food Vendorsw.e.f 28th September 2024: In order to encourage 'Hawkers' for registration, Food Authority has waived off the registration fees of hawkers w.e.f 28th September 2024 and grant them the registration certificate for five years [instead of giving option for selection of validity from one to five years] when applying for new Registration. This waiver of registration fee will also be applicable for renewal of registration certificate by all hawkers.

#### INFORMATION TECHNOLOGY

**1. Launch of Food Import Clearance System (FICS) 2.0:** The upgraded version of the Food Import Clearance System, FICS 2.0, has been officially launched to streamline and modernize the food import clearance process. This advanced system addresses the limitations of the previous version and introduces several new features aimed at ensuring faster, more transparent, and secure processing of food import applications.

#### **Key Features and Enhancements:**

- End-to-End Online System: The entire import clearance process is now fully automated, from filing the Bill of Entry at customs to receiving the No Objection Certificate (NOC) or Non-Conformance Report (NCR).
- **Enhanced Security:** The system features OTP-based login for enhanced security and seamless integration with other FSSAI portals like FoSCoS.
- **Smart Dashboard:** The Smart Dashboard presents essential data in clear, easy-to-understand graphical formats, providing a real-time overview of the application status, lifecycle tracking, and smart analytics.
- **Priority Indicators:** FICS 2.0 introduces a priority indicator system that allows applications to be processed based on their urgency and historical compliance, ensuring efficient resource allocation.
- **Integration with External Systems:** Seamless integration with systems such as CBIC's ICEGATE, DGFT, and InFoLNeT provides a comprehensive view of the import process and reduces duplication of efforts.
- **2. Launch of Food Import Rejection Alert (FIRA) Portal:** The Food Import Rejection Alert (FIRA) portal has been developed and launched as a critical tool for the rapid exchange of information on food import rejections at Indian borders. This portal aims to strengthen global collaboration on food safety and ensure that only safe and quality food products enter the Indian market.

#### **Key Features of the FIRA Portal:**

- **Rapid Information Exchange:** The portal facilitates the rapid exchange of information amongst global food safety authorities on food safety and health risks derived from rejected food consignments.
- **Real-Time Alerts:** FIRA provides real-time alerts on food import rejections, enabling relevant authorities and stakeholders to take immediate preventive and corrective actions.
- Comprehensive Database: The portal serves as a valuable database for tracking rejected food products, supporting risk management and enhancing traceability.
- **Public and Authority Access:** The portal provides access to both the general public and food safety authorities of other countries, promoting transparency and public awareness of food safety issues.

#### INTERNATIONAL COOPERATION

Memorandum of Understanding between Food Safety and Standards Authority of

# India (FSSAI) and the Brazilian Ministry of Agriculture and Livestock regarding cooperation in the area of food safety.

The Food Safety and Standards Authority of India (FSSAI) signed an MoU with the Ministry of Agriculture and Livestock (MAPA) of Brazil, at Bharat Mandapam, Pragati Maidan, New Delhi on 20 September, 2024.

The MoUsigned by Mr. Carlos Henrique BaquetaFávaro, Honourable Minister of Agriculture and Livestock of Brazil, was received in FSSAI and the said MoU is counter signed by Shri G. Kamala VardhanaRao, CEO, FSSAIon 20 September, 2024 in the presence of Brazilian Embassy officials.

#### The objectives of this MoU are:

- Hold joint meetings/workshops/seminars/visits for training and capacity building.
- Exchange of information and communication in the field of food safety.
- Strengthen the existing relationship between the Parties and improve cooperation in the field of food safety.
- Streamline and prioritize issues and demands of mutual interest in accordance with national capabilities and priorities.

#### **Areas of Cooperation under the MoU:**

- Import procedures, quality control operations, sampling, analysis, packaging and labelling.
- Other areas of interest of the Parties within their responsibilities that may be mutually determined.

This MoU came into force on **20 September**, **2024** and will remain in force for a period of 05 (five) years, automatically renewed for successive periods.
