Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023

10. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- He/ they shall not have had an opportunity to deal with the matters to which t he contract relates or who, in the course of his/ their duties as officers of t he FSSAI, expressed views on any or all of the matters under dispute or di fferences. A certification to this effect (as per Format 1.4) shall be taken f rom Arbitrators. The proceedings of the Arbitral tribunal or the award mad e by such Tribunal shall, however, not be invalid merely for the reason th at one or more arbitrators hadin the course of his service, an opportunity to deal with the matters to which the contract relates or who in the cours e of his/ their duties expressed views on all or any of the matters under di spute.
- An Arbitrator may be appointed notwithstanding the total no. of arbitration cas es in which he has been appointed in the past.
- Not be other than the person appointed by The Appointing Authority and that i f for any reason that is not possible, the matter shall not be referred to ar bitration at all.

2) Replacement of Arbitrators

If one or more of the arbitrators appointed as above refuses to act as arbitrato r, withdraws from his office as arbitrator, or in the event of the arbitrator dying , neglecting/ unable or unwilling or refusing to act for any reason, or his award being set aside by the court for any reason, or in the opinion of The Appointin g Authority fails to act without undue delay, the Appointing Authority shall app oint new arbitrator/ arbitrators to act in his/ their place in the same manner in which the earlier arbitrator/ arbitrators had been appointed. Such a re-constitu ted Tribunal may, at its discretion, proceed with the reference from the stage at which it was left by the previous arbitrator (s).

3) **Appointment of Arbitrator:**

- In cases where the total value of all claims in question added together does no t exceed Rs 50,00,000/ - (Rupees Fifty Lakh only), the Arbitral Tribunal sh all consist of sole Arbitrator. For this purpose, The Appointing Authoritysh all send to the contractor, within 60 days from the day of receipt of a writt en and valid notice for arbitration, a panel of at least four (4) names of reti red officers, duly indicating their retirement dates.
- The contractor shall be asked to nominate at least twonames out of the panel for appointment as his nominee within 30 days from the dispatch date of t he request by The Appointing Authority. The Appointing Authority shall ap point at least one out of them as the sole arbitratorwithin 30 days from th e receipt of the names of the contractor's nominees.
- In cases where the total value of all claims in question added together exceed s Rs 50,00,000/ - (Rupees Fifty Lakh only), the Arbitral Tribunal shall consi st of three (3) retired Officers of the FSSAI. For this purpose, The Appointi ng Authorityshall send a panel of at least four (4) names of such Officer(s) empanelled to work as Arbitrators duly indicating their retirement date to the contractor within 60 days from the day when a written and The Appointing Authority receives valid demand for arbitration.
- The contractor shall be asked to nominate at least 2 names out of the panel fo r appointment as his nominee within 30 days from the dispatch date of th e request by The Appointing Authority. The Appointing Authority shall app oint at least one out of them as the contractor's nominee. Itshall also sim ultaneously appoint the balance number of arbitrators either from the pan el or outside the panel, duly indicating the 'Presiding Arbitrator' from amo ngst the 3 arbitrators so appointed, within 30 days from the receipt of the names of Contractor's nominees.
- If the contractor does not suggest his nominees for the arbitral tribunal within the prescribed timeframe, The Appointing Authority shall proceed for app ointment of the arbitral tribunal within 30 days of the expiry of such time provided to the contractor.

6.5 Failure to appoint Arbitrators.

If The Appointing Authority fails to appoint an arbitrator within 60 (sixty) days, then su bject to the survival of this Arbitration Agreement, in international commercial arbitrat ion, the Supreme Court of India shall designate the arbitral institution for the appointm ent of arbitrators. In case of national arbitrations, the High Court shall designate arbitra I institutions. The Arbitration Council of India must have graded these arbitration instit utions. These arbitral institutions must complete the selection process within thirty da ys of accepting the request for the arbitrator's appointment.

6.6 The Arbitral Procedure

- 1) **Effective Date of Entering Reference:**The arbitral tribunal shall be deem ed to have entered the reference on the date on which the arbitrator(s) have r eceived notice of their appointment. All subsequent time limits shall be count ed from such date.
- 2) Seat and Venue of Arbitration: The seat of arbitration shall be the place f rom which the Letter of Award or the contract is issued. The venue of arbitrati on shall be the same as the seat of arbitration. However, in terms of section 2 0 of The Arbitration Act, the arbitrator, at his discretion, may determine a ven ue other than the seat of the arbitration without in anyway affecting the legal j urisdictional issues linked to the seat of the arbitration.
- 3) If the Adjudication and/ or Conciliation mechanisms had not been exhausted before such reference to Arbitration, the Arbitrator should ask the aggrieved p arty to approach designated authority for such mechanisms before the Arbitra tion proceedings are started.
- 4) The claimant shall submit to the Arbitrator(s) with copies to the respondent h is claims stating the facts supporting the claims along with all the relevant doc uments and the relief or remedy sought against each claim within 30 days fro m the date of appointment of the Arbitral Tribunal unless otherwise extension has been granted by Arbitral Tribunal.
- 5) On receipt of such claims, the respondent shall submit its defence statement and counter claim(s), if any, within 60 days of receipt of the copy of claims, unl ess otherwise extension has been granted by Arbitral Tribunal.
- 6) No new claim shall be added during proceedings by either party. However, a party may amend or supplement the original claim or defence thereof during a rbitration proceedings subject to acceptance by the Tribunal having due regar d to the delay in making it.
- 7) Statement of claims, counterclaims and defence shall be completed within si x months from the effective reference date.
- 8) **Oral arguments to be held on a day-to-day basis:** Oral arguments as fa r as possible shall be heard by the arbitral tribunal on a day-to-day basis, and no adjournments shall be granted without sufficient cause. The arbitrator (s) may impose an exemplary cost on the party seeking adjournment without sufficient cause.
- 9) Award within 12 (twelve) months: The arbitral tribunal is statutorily boun d to deliver an award within 12 (twelve) months from the date when the arbitr al tribunal enters reference. The award can be delayed by a maximum of six months only under exceptional circumstances where all parties consent to suc h extension of time. The court's approval shall be required for further extension n if the award is not made out within such an extended period. During the peri od of an application for extension of time is awaiting before the court, the arbitr rator's proceedings shall continue until the disposal of the application.
- 10) **Fast Track Procedure:** The parties to arbitration may choose to opt for a fa st-track procedure either before or after the commencement of the arbitration. The award in fast-track arbitration is to be made out within six months, and th e arbitral tribunal shall be entitled to additional fees. The salient features of th e fast-track arbitration are:

The dispute is to be decided based on written pleadings only.

- Arbitral Tribunal shall have the power to call for clarifications in addition to the written pleadings where it deems necessary.
- An oral hearing maybe held only if all the parties request or the arbitral tribun al considers it necessary.
- The parties are free to decide the fees of the arbitrator(s) for fast-track proced ure.

- 11) **Powers of Arbitral Tribunal to grant Interim Relief:** The parties to arbit ration may approach the arbitral tribunal for seeking interim relief on the grou nds available under section 9 of the act. The tribunal has the powers of a court while making interim awards in the proceedings before it.
- 12) **Confidentiality:** As provided in Section 42A of The Arbitration Act, all the de tails and particulars of the arbitration proceedings shall be kept confidential,ex cept in certain situations like if the disclosure is necessary for the implementat ion or execution of the arbitral award.
- 13) **Obligation During Pendency of Arbitration:** Performance of the contract shall, unless otherwise directed by the Authority, continue during the arbitratio n proceedings, and no payment due or payable by the Authority shall be withh eld on account of such proceedings, provided; however, it shall be open for Ar bitral Tribunal to consider and decide whether or not the performance of the c ontract or payment therein should continue during arbitration proceedings.

6.7 The Arbitral Award

- 1) In the case of the Tribunal, comprising of three members, any ruling on awar d shall be made by a majority of members of the Tribunal. In the absence of s uch a majority, the views of the Presiding Arbitrator shall prevail.
- 2) The arbitral award shall state item-wise the sum and reasons upon which it i s based. The analysis and reasons shall be detailed enough so that the award can be inferred from it.
- 3) It is further a term of this arbitration agreement that where the arbitral awar d is for the payment of money, no interest shall be payable on whole or any p art of the money for any period till the date on which the award is made in ter ms of Section 31 (7) (a) of The Arbitration Act.
- 4) The award of the arbitrator shall be final and binding on the parties to this co ntract.
- 5) A party may apply for corrections of any computational errors, typographical or clerical errors, or any other error of similar nature occurring in the award or interpretation of a specific point of the award to the Tribunal within 60 days of receiptof the award.
- 6) A party may apply to the Tribunal within 60 days of receiving the award to m ake an additional award as to claims presented in the arbitral proceedings but omitted from the arbitral award.

6.8 Savings

The Arbitral Tribunal shall decide any matter related to Arbitration not covered under this Arbitration Agreement as per the provisions of The Arbitration Act.

6.9 Cost of Arbitration and fees of the Arbitrator(s)

- The concerned parties shall bear the cost of arbitration in terms of section 3

 (A) of The Arbitration Act. The cost shall inter-alia include fees of the Arbitrat
 or. Further, the fees payable to the Arbitrator shall be governed by instruction
 s issued on the subject by the Authority and/ or the Government from time to t
 ime,in line with the Arbitration and Conciliation Act, irrespective of the fact wh
 ether the Arbitrator is appointed by the Authority or the Government under thi
 s clause or by any court of law unless directed explicitlyby Hon'ble court other
 wise on the matter.A sole arbitrator shall be entitled toa25% extra fee over su
 ch a prescribed fee.
- 2) The arbitrator shall be entitled to a 50 percent extra fee if the award is made within 6 months in terms of provisions contained in section 29(A) (2) of The Ar bitration Act.
- Besides the above, Arbitrator shall also be entitled to this extra fee in cases where Fast Track Procedure in terms of section 29 (B) of The Arbitration Actis f ollowed.

⁷ Defaults, Breaches, Termination, and closure of Contract

7.1 Termination due to Breach, Default, and Insolvency

7.1.1 Defaults and Breach of Contract

In case the contractor undergoes insolvency or receivership; neglects or defaults, or e xpresses inability or disinclination to honour his obligations relating to the performanc e of the contract or ethical standards or any other obligation that substantively affects the Authority's rights and benefits under the contract, it shall be treated as a breach o f Contract. Such defaults could include inter-alia:

1) **Default in Performance and Obligations:** if the contractor fails to del iver any or all of the Goods or fails to perform any other contractual obligation s (including Code of Integrity or obligation to maintain eligibility and Qualificati ons based on which contract was awarded) within the period stipulated in the contract or within any extension thereof granted by the Authority.

2) **Insolvency:** If the contractor being an individual or if a firm, any partner the reof, shall at any time, be adjudged insolvent or shall have a receiving order or or order for the administration of his estate made against him or shall take any proceeding for composition under any Insolvency Act for the time being in forc e or make any conveyance or assignment of his effects or enter into any assig nment or composition with his creditors or suspend payment or if the firm be d issolved under the Partnership Act, or

3) **Liquidation:** if the contractor is a company being wound up voluntarily or by order of a Court or a Receiver, Liquidator or Manager on behalf of the De benture-holders is appointed, or circumstances shall have arisen which entitle the Court or Debenture-holders to appoint a Receiver, Liquidator or Manager

7.1.2 Notice for Default:

As soon as a breach of contract is noticed, a show-cause 'Notice of Default' shall be iss ued to the contractor, giving two weeks' notice, reserving the right to invoke contract ual remedies. After such a show-cause notice, all payments to the contractor would be temporarily withheld to safeguard needed recoveries that may become due on invokin g contractual remedies.

7.1.3 Terminations for Default

1) **Notice for Termination for Default:** In the event of unsatisfactory res olution of 'Notice of Default' within two weeks of its issue as per sub-clause ab ove, the Authority, if so decided, shall by written Notice of Termination for Def ault sent to the contractor, terminate the contract in whole or in part, without compensation to the contractor.

2) Such termination shall not prejudice or affect the rights and remedies, in cluding under sub-clause below, which have accrued and/ or shall accrue to th e Authority after that.

3) Unless otherwise instructed by the Authority, the contractor shall continu e to perform the contract to the extent not terminated.

4) All warranty obligations, if any, shall continue to survive despite the term ination.

7.1.4 Contractual Remedies for Breaches/Defaults or Termination for Defaul t

If there is an unsatisfactory resolution within this period, the Authority shall take one; or more of the following contractual remedies.

1) Temporary withhold payments due to the contractor till recoveries due to invocation of other contractual remedies are complete.

2) Call back any loaned property or advances of payment, if any, with the le vy of interest at the prevailing rate(MIBID - Mumbai Interbank Bid Rate).

3) Recover liquidated damages and invoke denial clause for delays.

4) Encash and/ or Forfeit performance or other contractual securities.

5) Prefer claims against insurances, if any.

6) Terminate contract for default, fully or partially including its right for Risk -and-Cost Procurement as per following sub-clause.

7) **Risk and Cost Procurement:** In addition to termination for default, the Authority shall be entitled, and it shall be lawful on his part, to procure Goods similar to those terminated, with such terms and conditions and in such mann er as it deems fit at the "Risk and Cost" of the contractor. Such 'Risk and Cost Procurement' must be contracted within six months from the breach of Contra ct. The Contractor shall be liable for any loss which the Authority may sustain

on that account provided the procurement, or, if there is an agreement to pro cure, such agreement is made. The Contractor shall not be entitled to any gai n on such procurement, and the manner and method of such procurement sha II be in the entire discretion of the Authority. It shall not be necessary for the A uthority to notify the contractor of such procurement. It shall, however, be at t he discretion of the Authority to collect or not the security deposit from the fir m/ firms on whom the contract is placed at the risk and cost of the defaulted fi rm.

Note: Regarding the Goods which are not readily available in the mark et and where procurement difficulties are experienced, the period for making risk procurement shall be nine months instead of six months p rovided above.

8) Initiate proceedings in a court of law for the transgression of the law, tort, and loss, not addressable by the above means.

7.1.5 Limitation of Liability

Except in cases of criminal negligence or wilful misconduct, the aggregate liability of t he contractor to the Authority, whether under the contract, in tort or otherwise, shall n ot exceed the total Contract Price, provided that this limitation shall not apply to the c ost of repairing or replacing defective equipment, or to any obligation of the contractor r to indemnify the Authority concerning IPR infringement.

7.2 Termination for Default/ Convenience of Authority and Frus tration

7.2.1 Notice for Determination of Contract

1) The Authority reserves the right to terminate the contract, in whole or in part for its (the Authority's) convenience or frustration of contract as per subclause below, by serving written 'Notice for Determination of Contract' on the contractor at any time during the currency of the contract. The notice shall sp ecify that the termination is for the convenience of the Authority or the frustrat ion of the contract. The notice shall also indicate inter-alia, the extent to which the contractor's performance under the contract is terminated, and the date w ith effect from which such termination shall become effective.

- 2) Such termination shall not prejudice or affect the rights and remedies accrue d and/ or shall accrue after that to the Parties.
- 3) Unless otherwise instructed by the Authority, the contractor shall continue to perform the contract to the extent not terminated.
- 4) All warranty obligations, if any, shall continue to survive despite the terminat ion.
- 5) The Goods and incidental Works/ Services that are complete and ready in ter ms of the contract for delivery and performance within thirty days after the co ntractor's receipt of the notice of termination shall be accepted by the Authori ty as per the contract terms. For the remaining Goods and incidental Works/ S ervices, the Authority may decide:
 - To get any portion of the balance completed and delivered at the contract ter ms, conditions, and prices; and/ or
 - To cancel the remaining portion of the Goods and incidental Works/ Services a nd compensate the contractor by paying an agreed amount for the cost in curred by the contractor, if any, towards the remaining portion of the Goo ds and incidental Works/ Services.

7.2.2 Frustration of Contract

1) **Notice of Frustration Event:** Upon a supervening cause occurring after the effective date of the contract, including a change in law, beyond the control of either party whether as a result of the Force Majeure clause or within the scope of section 56 of the Indian Contract Act, 1872, that makes it impossible to perform the contract within a reasonable timeframe, the affected party shall give a 'Notice of Frustration Event' to the other party giving justification. The parties shall use reasonable efforts to agree to amend the contract, as may be necessary to complete its performance. However, if the parties cannot re ach a mutual agreement within 60 days of the initial notice, the Authority shall issue a 'Notice for Determining the contract' and terminate the contract due t o its frustration as in the sub-clause above.

2) However, the following shall not be considered as such a supervening cause.

Lack of commercial feasibility or viability or profitability or availability of fun ds

if caused by either party's breach of its obligations under this Contract or fai lure to act in good faith or use commercially reasonable due diligence to pre vent such an event.

7.2.3 Closure of Contract

No Claim Certificate and Release of Contract Securities

After mutual reconciliations of outstanding payments and assets on either side,the co ntractor shall submit a 'No-claim certificate' to the Authority requesting the release of its contractual securities, if any. The Authority shall release the contractual securities without any interest if no outstanding obligation, asset, or payments are due from the contractor. The contractor shall not be entitled to make any claim whatsoever against the Authority under or arising out of this Contract, nor shall the Authority entertain or consider any such claim, if made by the contractor, after he shall have signed a "No Claim" Certificate in favour of the Authority. The Contractor shall be debarred from dis puting the correctness of the items covered by the "No Claim" Certificate or demandin g a clearance to arbitration in respect thereof.

7.3 Closure of Contract

Financial Loss

The contract shall stand closed upon

- 3) successful performance of all obligations by both parties, including comp letion of warrantee obligations and final payment.
- 4) termination and settlements after that, if any, as per clause 7.1 or 7.2 ab ove.

Bidder Firm (manufacturer or prinicip al of authorised representative) shoul d not have suffered any financial loss for more than one year during the las t three years, ending on 31st March, 2021.

SERVICE LEVEL AGREEMENT (SLA)

(a). **Warranty/Training:** The Seller has to warrant that the Goods supplied u nder this Contract are new, unused, of the most recent or current models and incorporate all recent improvements in design and materials unless provided otherwise in the Contract

(b). **Warranty**: Warranty should be provided as mentioned against each equipment after successful installation of the instrument. Service and training during warranty period should be free of cost. This should cover the repair and maintenance with spare parts of t he equipment purchased under the Supply Order. This will also include:

(i) **Preventive Maintenance Service**: The Seller will provide a minimu m of two Preventive Maintenance Service visits during a year to the operating ba se to carry out functional check-ups and minor adjustments/tuning as may be req uired.

(ii) **Breakdown Maintenance Service**: In case of any breakdown of th e equipment/system, on receiving a call from the Buyer, the Seller is to provide maintenance service to make the equipment/system serviceable.

(iii) **Response time**: The response time of the Seller should not exceed 48 hours from the time the breakdown intimation is provided by the Buyer.

(iv) Serviceability of 90% per year is to be ensured. This amounts to total maximum downtime of 37 days per year. Also unserviceability should not exceed 2 working days at one time. Required spares to attain this serviceability may be stored at site by the Seller at his own cost. Total down time would be calculated at the end of the year. If downtime exceeds permitted downtime, Liquidated Da mages would be applicable for the delayed period.

(v) Maximum repair turnaround time for equipment/system would be 3 day s. However, the spares should be maintained in a serviceable condition to avoid complete breakdown of the equipment/system.

(vi) **Technical Documentation**: All necessary changes in the documentati on (Technical and Operators manual) for changes carried out on hardware and so ftware of the equipment will be provided.

(vii) During the Warranty period, the Seller shall carry out all necessary serv icing/repairs to the equipment/system under Warranty at the current location of t he equipment/system. Prior permission of the Buyer would be required in case c ertain components/sub systems are to be shifted out of location. On such occasions, before taking over the goods or components, the Seller will give suitab le bank guarantee to the Buyer to cover the estimated current value of item bein g taken.

(viii) The Buyer reserves its right to terminate the maintenance Supply Order at any time without assigning any reason after giving a notice of 1 month. The S eller will not be entitled to claim any compensation against such termination. Ho wever, while terminating the Supply Order, if any payment is due to the Seller for maintenance services already performed in terms of the Supply Order, the same would be paid to it as per the Supply Order terms.

(c). **Training**: Training for the operation of instrument, software, data evaluation, trouble shooting and development of analytical methods will be provided free of cost during the warranty period.

(d). **Uptime**. The successful bidder will guarantee to provide 9 0% uptime of all the systems during warranty and subsequent AMC. I n case of failure to do so, proportionate payment will be deducted fr om the bank guarantee/payment due to the successful bidder.
