# Minutes of the 46<sup>th</sup> meeting of the Food Authority held on March 07, 2025 at 12:00hrs through physical cum virtual mode

The forty sixth meeting of the Food Safety and Standards Authority of India (FSSAI) was held on 7<sup>th</sup> March, 2025 at 12:00 pm through physical cum virtual platform at Ministry of Health and Family Welfare, Room No. 155, A-Wing, Committee Room, 1<sup>st</sup> Floor, Nirman Bhawan, New Delhi under the chairmanship of Ms. Punya Salila Srivastava, Secretary, Health and Chairperson, FSSAI. The list of participants is at **Annexure -1**.

Shri G. Kamala Vardhana Rao, Chief Executive Officer (CEO) welcomed Chairperson and the members of the Authority to the meeting. Further, he informed that CEO's report is tabled for information of all the members and requested Director (Sc. & Std.) to proceed with the agenda items.

Further, the Chairperson expressed her concern to reach to the lowest level of personnel getting affected in the food chain and directed to conduct wider and frequent consultations at suitable venue with relevant stakeholders before publishing any draft/final regulation. These consultations should involve ground level participation including MSMEs, related to the issue in consideration and not restricted only to large industry associations like CII, FICCI etc.

The 47<sup>th</sup> Session of Codex Alimentarius Commission (CAC47) held at Geneva, Switzerland from 25<sup>th</sup> – 30<sup>th</sup> November 2024. #### 4. TRAINING AND CAPACITY BUILDING

- ➤ In the FY 2024-25, a total of 2,12,709 food handlers have been trained through 3740 training which include 21,000 street food vendors.
- ➤ FSSAI and The Brihanmumbai Municipal Corporation (BMC) signed an MoU to train more than 10,000 street food vendors in the city on essential food safety and hygiene practices.

#### 7. SBCD

- i. **FSSAI set up a Food Safety Pavilion at Mahakumbh 2025 in Prayagraj,** from January 13, 2025 to February 26, 2025. The pavilion highlighted activities of FSSAI, including *Eat Right India*, *Aaj Se Thoda Kam*, *Fortification*, *Adulteration Check* and *Millets*. As part of this, 150 Nukkad Natak (street plays) were performed at the pavilion to raise awareness among the general public about food safety, adulteration, and other related issues.
- ii. FSSAI participated in the 43<sup>rd</sup> India International Trade Fair 2024 from 14<sup>th</sup> November 2024 to 27<sup>th</sup> November 2024 at Pragati Maidan, New Delhi. The

Pavilion of Ministry of Health and Family Welfare was showcased on the theme - "One Heath". In order to spread awareness about the various aspects of food safety, Mobile Testing Lab (Food Safety on Wheels) was deployed for performing on the spot testing of food under various categories and Nukkad Nataks were performed in the pavilion.

- iii. **FSSAI participated in the National Book Fair 2025**, held from 1<sup>st</sup> to 9<sup>th</sup> February 2025 at Bharat Mandapam, New Delhi. FSSAI's engaging stall was located in the Kids Pavilion, where it captivated young audiences through a series of interactive quizzes, engaging videos, and live demonstrations of Magic Box.
