
Minutes of the 47th meeting of the Food Authority held on August 06, 2025 at 15:00 hrs through physical cum virtual mode

The forty seventh meeting of the Food Safety and Standards Authority of India (FSSAI) was held at 03:00 pm on 06th August, 2025 through physical cum virtual platform at Ministry of Health and Family Welfare, Room No. 155, A-Wing, Committee Room, 1st Floor, Nirman Bhawan, New Delhi under the chairmanship of Ms. Punya Salila Srivastava, Secretary, Health and Chairperson, FSSAI. The list of participants is at **Annexure -1**.

Shri Ganji Kamala Vardhana Rao, Chief Executive Officer (CEO) welcomed the Chairperson and the members of the Authority to the meeting. Further he informed that CEO's report is tabled for information of all members and requested to proceed with the agenda items.

	The CEO's report outlining the actions taken and developments since the last meeting of the Authority was tabled for the information of the members. The report highlighted notable growth in the licensing and registration of food businesses, particularly under schemes for women, transgender individuals, and hawkers. Key advisories were issued, including the discontinuation of misleading "100%" labels on food products and enhanced monitoring to curb the use of artificial ripening agents in fruits. Intensive sampling and targeted surveillance drives were conducted for commodities such as jaggery, paneer and dairy analogues, used cooking oil, ghee, and others.			
	Several regulations were notified, including amendments related to the use of recycled plastics in food packaging and standards for alcoholic beverages. Capacity building activities included in-house training on the WTO-SPS Agreement and its relevance to food safety. National stakeholder consultations were held across multiple cities namely Delhi, Mumbai, Goa, Hyderabad, Kolkata, and Jaipur covering topics such as sustainable packaging, traditional foods, and proposed new and amendments in existing food standards. Consultations with States/UTs were also held during the Central Advisory Committee meeting on 27.05.2025. FSSAI received a Special Mention for Citizen-Government Engagement from The Civic Innovation Foundation (Civis) for its robust stakeholder consultation process aligned with OECD guidelines.			

India's active participation in Codex activities continued, with its leadership in developing standards for millet and fresh dates receiving international recognition. Quality assurance efforts included expansion of food testing infrastructure, festive surveillance drives, and training programs for laboratory personnel. Over 25 lakh food handlers have been trained under the FoSTaC programme to date. Significant IT upgrades were implemented, including platforms for reporting misleading claims and tracking Eat Right India initiatives. Public outreach efforts intensified through campaigns such as #StopObesity, Eat Right Mela, and World Liver Day, with nearly 2,000 Eat Right certifications awarded during the reporting period. Authority took note of the CEO's report. 1.2. Recent Advisors/Orders:

- i. FSSAI issued an Advisory dated 28th May, 2025 directing the FBOs to discontinue the term 100 % on Food product labels and related promotional materials.
- ii. FSSAI through Order dated 16th May, 2025 mandated FBOs to submit Closure Report on expiry of FSSAI License/Registration.

1.4 Following FBO meets were conducted from March to July, 2025

- a. E commerce 02.06.2025 & 08.07.2025 To understand their concerns and update the regulatory provisions laid down under FSSR for compliance
- b. Dairy sector including Dairy analogue 07.04.2025 to discuss the compliance with the provisions of analogue in dairy context laid down under FSSR
- c. HoReCa sector (Hotel, Restuarant and Caterer) 18th, 19th, 20th and 26th March 2025 To apprise regulatory requirements especially related to menu labelling, use of dairy analogue and their declaration, use of food grade packaging etc.
- d. Packaged drinking water and mineral water 25th April 2025 To apprise updated regulatory requirements like Omission of BIS certification, seeking comments on restriction of registration etc.

2. REGULATION

2.1. Gazette Notification:

Three final regulations and one guideline, namely, (i) Food Safety and Standards (Packaging) First Amendment Regulations, 2025 related to use of recycled plastics in food packaging, (ii) Food Safety and Standards (Alcoholic Beverages) First Amendment Regulations, 2025, relating to related to standards of Mead (Honey wine), Craft Beer, Indian liquors and definition of Low Alcoholic Beverages/ RTD, Wine based Beverages and, Country Liquors etc, (iii) Food Safety and Standards (Food Products Standards and Food Additives) First Amendment Regulations, 2025 relating to standards for Refractive Index range for Palm oil, Palmolein, Palm kernel oil and Palm Superolein; Meat sausage; Dehydrated tarragon; PDW; Food colors; Appendix A and Appendix C, (iv) Guidelines for acceptance of recycled Polyethylene terephthalate (PET) as Food Contact Material (FCM-rPET), have been notified.

One draft regulation, namely, Draft Food Safety and Standards (Food Products Standards and Food Additives) Amendment Regulations, 2025 relating to Cheese powder etc. has been published in the Gazette of India for inviting comments and suggestions from stakeholders.

2.2. Capacity Building:

An in-house training session was organized on the 'WTO-SPS Agreement (Application of Sanitary and Phytosanitary measures) and its relevance to food safety' for approximately 50 officials on 27th March 2025. The primary objective of the session was to enhance participants' understanding of the agreement's relevance to food safety.

The training covered several important topics, including an overview of the SPS Agreement, basic obligations, and key articles such as harmonization, risk assessment and transparency.

Codex noted the importance of India's initiative and published it on the Codex website.

3. STANDARDS

3.1. Scientific Committee and Scientific Panel Meetings

During this period, **2 Scientific Committee and 60 Scientific Panel meetings** were held, making significant contributions to the development of draft and final standards, along with suggestions on food safety issues.

3.2. Expert Committee meetings

During this period 32 expert committee meetings were held on various subjects, including product and claim approvals.

3.3. Stakeholder Consultations

- i. National Stakeholder Consultation On Sustainable Packaging for Food Business: Emerging Global Trends and Regulatory Framework
 - National Stakeholder Consultation on "Sustainable Packaging for Food Business: Emerging Global Trends and Regulatory Framework" was held on 16.04.2025 at MMRDA Auditorium, Mumbai, Maharashtra.
 - The consultation brought together over 1500 stakeholders representing food businesses, packaging industries, recycling associations, regulatory bodies, environmental organizations, consumer groups, to deliberate on the future of sustainable food packaging in India.
- ii. Stakeholder consultations to discuss the proposed new standards and amendments in the existing standards under Food Safety and Standards Regulations (FSSR)

National/regional stakeholder consultations to discuss the proposed new standards and amendments in the existing standards under FSSR were held on 07.04.2025 and

16.05.2025 in Delhi, and subsequently on 25.05.2025 in Goa, 26.05.2025 in Hyderabad, and 30.05.2025 in Kolkata.

iii. Consultative Stakeholders Meeting on Traditional Foods and Global Standards

A Consultative Stakeholders Meeting on Traditional Foods and Global Standards with the emphasis on Ayurveda Aahara was held on 29.07.2025 at NIA, Jaipur.

iv. Meeting with consumer organizations to discuss the proposed new standards and amendments in the existing standards under Food Safety and Standards Regulations (FSSR)

A meeting with consumer organizations to discuss the proposed new standards and amendments in the existing standards under FSSR was held on 20.05.2025 at FSSAI, FDA Bhawan, New Delhi.

v. Consultations with States/Union Territories

Consultations with States/Union Territories was done in the Central Advisory Committee on 27.05.2025 to discuss the proposed new standards and amendments in the existing standards under FSSR.

vi. Stakeholder meetings conducted within Scientific Panel meetings

- a. Two stakeholder consultations were held in the 12th (18.03.2025) and the 13th meeting (26.05.2025) of SP on Antibiotic Residues (SP-03) for review of Sub-Regulation 2.3.2 of the FSS (Contaminants, Toxins, and Residues) First Amendment Regulations, 2024.
- b. One stakeholder consultation was done in the 36th meeting (24.06.2025) of SP on Water and Beverages with the Coffee Board on the draft standards of Green Coffee.

3.4. Codex related activities

• 88th Session of the Executive Committee of the Codex Alimentarius Commission

Indian Delegation participated in the 88th Session of the Executive Committee of the Codex Alimentarius Commission (CCEXEC88), held from 14 to 18 July 2025 in Rome, Italy, as a member elected on a geographical basis. In the session, India's progress on the group standard for whole millet grains, chaired by India with support from Mali, Nigeria, and Senegal was appreciated. India's work on finalizing standards for fresh dates was also endorsed for adoption at CAC48. Indian delegation contributed to discussions on the Codex Strategic Plan 2026–2031 and emphasized the need for outcome-based indicators. India's regional capacity building efforts were also shared with the international delegates present in the session, and greater use of the Codex Trust Fund (CTF) was encouraged.

4. QUALITY ASSURANCE

4.1. Inauguration of Microbiology Lab:

7. SOCIAL AND BEHAVIOURAL CHANGE DIVISION

7.1. #StopObesity #FightObesity Campaign

- Stop Obesity & Fight Obesity campaign has been launched on social media to promote Hon'ble Prime Minister Narendra Modi's vision of reducing obesity and cutting down on excessive oil consumption. As part of this effort, informative videos, expert bytes, celebrity videos, bytes of common people including women, children & college students are being created and shared in different Indian languages on various social media platforms.
- 'Awareness Initiative to Stop Obesity by Eating Safe and Healthy' Campaign was launched by Hon'ble Union Minister for Health and Family Welfare, Shri J P Nadda ji on World Food Safet Day 2025.
- A media campaign on Obesity over Radio FM channels in 78 cities on 83 FM stations and audio announcement across 189 railway stations was carried out in June-July 2025.
- The Sugar Board & the Oil Board are designed and circulated to different departments and States/UTs to raise awareness about excessive sugar & oil intake. These boards are displayed across schools, offices & public spaces.
- An online quiz series named 'Eat Right Quiz on Obesity' has been launched on MyGov portal to engage people in a fun & interactive way while educating them on different aspects of obesity and healthy living.
- Insightful sessions on Obesity have been conducted to raise awareness about the growing concerns surrounding obesity and the importance of adopting healthier eating habits.

7.2. Social Media

Over 1300 posts were circulated on different Social Media Platforms to create awareness about Food Safety, educate about different campaigns and inform about FSSAI's notifications and advisories.

Collaborations with public figures such as TV anchors, FM RJs, Chefs, Sports persons are executed to make the reach wider.

7.4. Ayushman Bhav Samvaad

The Ayushman Bhav Samvaad webinar series of 100 episodes began on 29th March 2025, aimed at spreading awareness on food safety and nutrition among citizens including college students, FSSAI stakeholders, ASHA workers and community health workers. Total 18 webinars have been conducted so far on different important topics related to Food Safety with an estimated participation of 20,000 people as audience.

7.5. World Liver Day

FSSAI under the aegis of Ministry of Health and Family Welfare (MoHFW) organised Online Pledge Programme on World Liver Day (19 April 2025). The awareness campaign regarding Liver Health was carried out on different Social Media Platforms of FSSAI.

FSSAI had set up an informative exhibition showcasing millets and liver-friendly diets on the event "Liver Health Pledge Ceremony" which was organised by MoHFW at Nirman Bhawan, New Delhi, on 21 April 2025.

7.6. Events, Exhibitions & Activities

FSSAI participated in AAHAR 2025 held from March 4, 2025 to March 8, 2025 at Bharat Mandapam, Pragati Maidan, New Delhi. Awareness activities were conducted about food safety including hygiene practice, food labelling, packaging regulation and promotion of quality standards.

FSSAI has taken a new Social Media Campaign named "Shree Anna Ki Baat FSSAI Ke Sath" - a video series for creating awareness on millets.
