Subject: Constitution of Food Safety Coordination Committee (FSCC) for implementation and management of food safety emergencies-reg.

The Food Safety and Standards Authority of India (FSSAI) has developed a comprehensive framework for the National Food Safety Emergency Response (FSER) System, detailing multi-sectoral coordination, roles, responsibilities, and management actions during food safety emergencies. This framework is formulated in accordance with Section 16 (3) (b) (v) & (vi) of the Food Safety and Standards Act, 2006 and encompasses the collection, collation, analysis, and summarization of relevant scientific and technical data, particularly for identifying emerging risks. Additionally, it provides provision for the establishment of a rapid alert system to ensure timely and effective response measures. The detailed framework of FSER system is enclosed at **Annexure A**.

2. The FSER framework also outlines the **establishment of the Food Safety Coordination Committee (FSCC)** under para 5.1.4 of the framework. Accordingly, the FSCC has been constituted under this framework for coordinating and managing food safety emergency response activities through multi-sectoral coordination, timely decision-making, and the efficient execution of response measures as mandated under the framework.

4. The role and responsibilities of FSCC as detailed in the para 5.1.4 of FSER Framework are given below:

- i. To take decisions for controlling and management of food safety emergency situations based on the recommendation of FSRAC
- ii. Direct the planned measures to related agencies in implementing control and monitoring actions
- iii. Monitor, evaluate and review the measures used that are fit to the situation.
- iv. Consider and make a decision when the situation has been controlled in order to increase or decrease the response level, including incident closure.
- v. Advice for policy making for management and control of food safety emergency situation from time to time
- vi. Support finances and other resources, if required, for operations
- vii. Consider information related to range of hazards, its magnitude and affected people while making decisions.
- viii. Undertake any other functions with approval of the Food Authority, based on evolving food safety challenges and regulatory requirements.
