Subject : Preparation of panels for Technical Officers in the Food Safety and Standards Authority of India on contract basis - reg.

The Food Safety and Standards Authority of India (FSSAI) is an autonomous statutory Authority set up under the Food Safety and Standards Act, 2006 for laying down science based standards for articles of food and to regulate their manufacture, storage, distribution, sale and import, to ensure availability of safe and wholesome food for human consumption.

2. Applications are invited from Indian nationals for preparing a panel of Technical Officers on contract basis. The position of Technical Officers has All India transfer liability.

3. **Remuneration-** A consolidated sum of Rs.25,000/- per month shall be paid. The payment shall be subject to deduction of TDS as applicable. The contractual employee shall not be exempted from taxation as per income tax laws of Government of India.

4. **Minimum educational qualifications-** Master's Degree or equivalent from a recognised university or institution in the field of Chemistry/Bio chemistry/Food Technology/Edible Oil Technology/Microbiology/Dairy Technology/ Agriculture Sciences/ Veterinary Science/Bio-technology or any other subject related to food science.

Note-1: Candidates who have not acquired/will not acquire the educational qualification as on the closing date of receipt of application will not be eligible.

Note-2: As per Ministry of Human Resource Development Notification No. 44 dated 01.03.1995 published in Gazette of India edition dated 08.04.1995, the Degree obtained through open Universities/ Distance Education Mode needs to be recognized by Distance Education Council, IGNOU.

Note-3: All candidates will be required to produce the relevant Certificate in Original such as Mark sheets, Provisional Certificate, as proof of having acquired the minimum educational qualification etc. at the time of interaction failing which they would not be allowed to appear before the interview panel.

5. **Age:** Maximum Age limit is 40 years. The crucial date for consideration is the date of interview.

6. The Candidates fulfilling the educational qualifications and experience, if any and who can report for duties immediately in the event of their selection may walk-in alongwith biodata (4 copies) in prescribed format (Annexure-1) and original documents at Food Safety
