## **CIRCULAR**

Subject:

Filling up of various posts in Food Safety and Standards Authority of India on deputation basis.

It is proposed to fill up various posts as indicated in Annexure1 in the Food Safety and Standards Authority of India. The Food Safety and Standards Authority of India (FSSA) is an autonomous statutory Authority set up under the Food Safety and Standards Act, 2006 for laying down science based standards for articles of food and to regulate their manufacture, storage, distribution, sale and import, to ensure availability of safe and wholesome food for human consumption.

- 2. The Pay of the officials selected on deputation will be governed by provisions laid down in the Department of Personnel and Training's OM No. 2/8/97-Estt.(Pay-II) dated 11.3.1998, as amended from time to time.
- 3. The period of deputation, including the period of deputation in another ex cadre post held immediately proceeding this appointment in the same or some other organization/Department shall not exceed three years. The maximum age limit for appointment on deputation shall be 56 years. Accordingly persons who will be crossing the age of 56 years, on the last day of receiving the applications need not apply.
- 4. Officers who volunteer for the post(s) will not be permitted to withdraw their names later. Only such recommendations as are accompanied by the requisite personal data in Annexure II will be considered.
- 5. It is requested that wide publicity may be given to the vacancy circular amongst staff under your administrative control and, applications in the given proforma (Annexure II) alongwith complete and up to date CR Dossiers of the officers who can be spared in the event of their selection, may be sent to this Ministry latest by 15 November 2008. Application received after the last date or without the CR dossiers or otherwise found incomplete will not be considered. While forwarding the applications, it may also be verified and certified that the particulars furnished by the officers are correct and no disciplinary proceedings are either pending or contemplated against him/her. The integrity of the officers may also please be certified. It may also be confirmed that no major/minor penalty has been imposed on him/her during the last ten years.

**Note:** Those who have applied in response to Vacancy Circular dated 14<sup>th</sup> March, 2008 and 7<sup>th</sup> April 2008 need not apply afresh.
