NOTICE (DR-04/2021)

Subject: Declaration of result of Skill Test (Stenography/Typing) for the post of Personal Assistant (Advt No. DR-04/2021).

Food Safety and Standards Authority of India (FSSAI) conducted the Computer Based Test on 29.03.2022 for filling up of 26 posts of Personal Assistant against Advertisement No. DR-04/2021 and the result was declared on 06.07.2022. A total of 269 candidates were shortlisted for appearing in the Skill Test.

2. Skill test was conducted on 14.01.2023 and a total of 135 candidates (English-93 & Hindi-42) were appeared for the test.

3. The following criteria have been adopted for evaluation of the Skill Test:

- i. Up to 5% mistakes in Stenography and 7% in Typing for UR category candidates.
- ii. Up to 7% mistakes in Stenography and 10% in Typing for all reserved category candidates.

4. Based on the above mentioned criteria, the number of candidates qualified the Skill Test is as under:
